


Figure 1. Power Dissipation vs. Ambient Temperature




Figure 4. Rel. Luminous Intensity vs. Angular Displacement




Figure 2. Forward Current vs. Ambient Temperature




Figure 5. Percentage Total Luminous Flux vs. Total Included Angle for 90 $^{\circ}$ emission angle




Figure 3. Forward Current vs. Pulse Length





Figure 6. Thermal Resistance Junction Ambient vs. Cathode Padsize
