

#### **Description**

The LH1522 dual 1 Form A relays are SPST normally open switches that can replace electromechanical relays in many applications. They are constructed using a GaAIAs LED for actuation control and an integrated monolithic die for the switch output. The die, fabricated in a high-voltage dielectrically isolated technology is comprised of a photodiode array, switch control circuitry, and MOSFET switches. In addition, the LH1522 SSRs employ current-limiting circuitry, enabling them to pass FCC 68.302 and other regulatory surge requirements when overvoltage protection is provided.




Figure 1. Recommended Operating Conditions




Figure 3. LED Current for Switch Turn-on vs. Temperature




Figure 2. LED Voltage vs. Temperature




Figure 4. Current Limit vs. Temperature




Figure 5. LED Dropout Voltage vs. Temperature




Figure 8. Switch Capacitance vs. Applied Voltage




Figure 6. ON-Resistance vs. Temperature




Figure 9. Insertion Loss vs. Frequency




Figure 7. Variation in ON-Resistance vs. LED Current




Figure 10. Output Isolation








Figure 11. Leakage Current vs. Applied Voltage




Figure 14. Switch Offset Voltage vs. Temperature




Figure 12. Leakage Current vs. Applied Voltage at Elevated Temperatures




Figure 15. Switch Offset Voltage vs. LED Current




Figure 13. Switch Breakdown Voltage vs. Temperature




Figure 16. Turn-on Time vs. Temperature




Figure 17. Turn-off Time vs. Temperature




Figure 18. Turn-on Time vs. LED Current






Figure 19. Turn-off Time vs. LED Current
